Other than this, the Board wishes to inform that the Company is actively considering various options to meet the requirements of Rule 1314 of the Listing Manual of SGX-ST pursuant to the MTP and Financial Entry exit criteria within 36 months from 6 June 2019 and 4 December 2019 respectively and would update the shareholders in due course.
